Free extension of the warranty period

Just how pleasant it is to have warranty protection, often is not noticed until it is lacking. Consequently, for many of our extraction units* we offer – completely free of charge and with no obligation on your part – an **extension** of the legal **warranty period** from **12 to 24 months**. The scope of supply of your new extraction unit includes a registration card.

To obtain the warranty extension, simply register your new welding fumes extraction unit online.

- » Call up the link printed on the card
- » Log in and register your product
- » You will then automatically receive a confirmation together with the warranty certificate.



If you conclude a **KEMPER service contract**, the **warranty period** even increases to a total of **36 months**.

Extension for central suction and filter units

An extension of the warranty period is also possible for central suction and filter units. Simply conclude a **service contract**. Depending on the contract period, the warranty is **ex-tended to 24 or 36 months**.

The air systems safety check

The air systems safety check is an inspection prescribed annually for extraction units in Germany, which is specified by the liability insurance association in DGUV regulation 109-002 in point 3.7.2.



The electrical safety check

The electrical safety check is an annually prescribed inspection in Germany for mobile, plug-guided devices and is specified by the liability insurance association in DGUV regulation 3.



Filter change service

Your filter system only provides low extraction capacity? Then, often, it's time for a filter change. Benefit from our professional and fast filter change service that includes **the following:**

- » Supply of high-quality (KEMPER original) filter elements
- » Professional and quick replacement of the filters
- » Acceptance of the newly equipped filter system

If original parts are no longer available, e.g. due to technical progress, successor articles suitable for use in the units/systems will also be supplied or the unit/ system will be retrofitted accordingly
